## Application Checklist

Use the following checklist to ensure that your application is complete and all supporting materials have been requested.

- Submit the Unified Application for Conservatory Admission and the \$100 application fee (or a completed College Board fee-waiver request form). **Deadline: December 1** (November 1 for Early Review).
  - \* All voice and jazz applicants will submit a screening recording. See the audition request section of the application instructions for details.
- Request two music teacher recommendations. **Deadline: December 1.**
- Request secondary school report and transcript. **Deadline: December 1.**
- Request SAT I/ACT score report(s) be sent to Oberlin. (This is not required for students who are submitting TOEFL results.) **Deadline: December 1.** SAT Code: 1587. ACT Code: 3304.
- Submit photo (with instrument).
- DOUBLE-DEGREE APPLICANTS ONLY: Submit College of Arts and Sciences application and all supporting materials. Submit a \$35 application fee to the College of Arts and Sciences admissions office; this fee is in addition to the Conservatory's \$100 fee, which is submitted online as part of the Unified Application process. **Deadline: December 1.**
- ON-CAMPUS AUDITION VOICE APPLICANTS: Submit pre-screening recording and Audition Materials Mailing Form. **Deadline: December 1. (November 1 Early Review)**
- TRANSFER APPLICANTS ONLY: Confidential Transfer Report and request college transcript. **Deadline: December 1.**
- JAZZ APPLICANTS ONLY: Download MP3 file of jazz accompaniment. *On-Campus Audition Jazz Applicants:* Submit pre-screening recording and Audition Materials Mailing Form. **Deadline: December 1. (November 1 Early Review)**
- TIMARA/COMPOSITION APPLICANTS ONLY: Submit TIMARA/Composition scores with the Audition Materials Mailing Form. **Deadline: February 1.**
- MASTER OF MUSIC IN HISTORICAL PERFORMANCE APPLICANTS ONLY: Request three music teacher recommendations; submit complete set of official college/university academic transcripts (secondary school transcripts and SAT or ACT scores are not required). **Deadline: December 1.**

- CHANGE OF STATUS: Follow all instructions found at [www.oberlin.edu/con/admissions/ChangeofStatus.htm](http://www.oberlin.edu/con/admissions/ChangeofStatus.htm).
- INTERNATIONAL APPLICANTS ONLY: Submit results of the Test of English as a Foreign Language (TOEFL). **Deadline: December 1.** For more information about the TOEFL, visit [www.ets.org/toefl/](http://www.ets.org/toefl/). All international applicants must submit the International Student Supplement and the Certification of Finances form, regardless of whether they are requesting financial aid. International applicants who are requesting financial aid must also file the International Financial Aid Application. - If you intend to apply for *any* form of financial aid (merit or need based), then you must file the Financial Aid PROFILE with the College Scholarship Service. **Deadline: February 15.**
- If you are requesting *need-based* financial aid, then you must file the Free Application for Federal Student Aid (FAFSA) with the federal processor. **Deadline: March 1.**
- If you are requesting financial aid and your parents are separated or divorced, your non-custodial parent must submit Oberlin's Non-Custodial Parent Statement to the Office of financial Aid. **Deadline: February 15.**
- If you are requesting financial aid, submit a signed copy of your federal tax return and a signed copy of your parents' federal tax return plus copies of their W2 forms; to the Office of Financial Aid. **Mail on or before April 15.**
