Michael Bobker, Mira Inbar, Claire Jahns, Rosallyn Johnson, Peter Lavigne (resigned, Sept 04), Peter Racher, and Michael Murray were unable to attend. David Orr joined the meeting for a lunch-time presentation by and discussion with about a dozen students. Carl McDaniel and Susan Bernat were asked and agreed to serve as Chair and Vice Chair, respectively, for the coming year.

#### **Activities**

1) The E Steering Committee prepared and circulated among alums a resolution that strongly endorsed the implementation of Oberlin's Trustee approved Environmental

Policy. The resolution with 146 signatures was given the Board of Trustees and President Nancy Dye in December 2004.

- 2) EnviroAlums established a fund for supporting student activities that promote environmental education and implementation of Oberlin's Environmental Policy. Donations of \$1,285 were given and \$200 was provided in August 2005 to the Orientation Committee of the student Environmental Policy Implementation Group for a new-student program on environmental projects and organizations.
- 3) EnviroAlums organized and provided funds for a May 2005 Alumni Reunion symposium entitled, "Social Justice and the Environment: Oberlin & Beyond." Terri Swearingen (guest speaker) and John Petersen '88 inspired all present as they placed environmental concerns in an overarching context in which Oberlin can champion its deep history of, and concern for, social justice.
- 4) EnviroAlums worked with Belden Paulson '50 to coordinate a meeting following the "Social Justice and the Environment: Oberlin & Beyond" symposium to discuss implementing Oberlin's Environmental Policy.
- 5) The *Environmental Studies Program Annual Newslettter* (Spring 2005) published "EnviroAlums at Three Years" by Carl McDaniel.
- 6) EnviroAlums are making an on-going effort to have alums be aware of Oberlin's EP and the importance of implementation. Groups have meet in New York City, Chicago, and other places to discuss environmental issues in general and Oberlin's environmental programs in particular.
- 7) Many EnviroAlums members have environmentally oriented professions and others have strong interests in environmental topics. Their many activities are important and support Oberlin's effort to effectively address environmental issues.
