The certificate approaches listed on this page are mainly for individuals entering the field of education. There are some instances where certified educators seek additional certification through one of these approaches. All alternative certificates must be requested by the specific employing entity as indicated with the approach. An individual who begins an alternative approach, must complete it in its entirety or they will not be eligible to begin another alternative certificate approach for 5 years.

Conditional Certificate in a teaching field (CCTF), completing a program through Alabama-approved alternative Teacher Preparation Organization (ATPO). Since CCTF certificates must be requested by an employing Alabama city/county superintendent, an individual should contact the school system in which employment is desired for information concerning certificate eligibility.

The only Alabama approved ATPOs at this time are iteach Alabama and #T.E.A.C.H.

The Initial Two-Year certificate is for all applicants who have completed a teacher preparation program and are new to the teaching profession. If you have taught for less than two years, you are considered new to the profession in Alaska.

An intern program offers an alternative route if you already hold a bachelor's degree and want to teach as soon as possible. You may have prior experience working in a classroom as an aide or another role assisting students. You may have worked with young people in an afterschool or interest-based program. Or maybe you just always knew that you wanted to be a teacher. As an intern teacher, you are employed as the teacher of record in a classroom while you complete your program and earn a teacher's salary. Most intern programs are two years long, with an early completion option.

The traditional post-baccalaureate program (sometimes called a "fifth-year program") is the most common pathway into teaching in California. Like a residency program, it takes place after you have completed your undergraduate degree, but in a traditional program, the clinical experience does not usually span an entire school year. This pathway provides an academic and theoretical focus in addition to classroom-based field and student teaching experiences. Earning a Preliminary teaching credential in this way typically takes one to two years, or it can take longer if you're pursuing it on a part-time basis.

Teacher residency programs are inspired by the medical school approach to training doctors, where instruction and practice are combined. Starting after you earn your bachelor's degree, as a teacher resident you'll be teaching alongside an experienced mentor teacher for at least one full school year in the district where you'll ultimately serve as teacher of record, all while completing coursework to earn your Preliminary credential. Residency programs are collaboratively administered through a credential program and a local educational agency (a school district, county office of education or charter school).

91 Day option:

To qualify for an Initial License and be eligible for the 91 Days option, a Delaware district/charter school agrees to provide mentoring and professional development to the prospective educator who:

- Has a Bachelor's degree (related to area of teaching) from a regionally accredited college/university;
- Will pass the required Praxis II test in the relevant content area; and
- Is hired as a long-term substitute teacher for 91 days, in one assignment, and may not be employed as the teacher of record.

Upon being hired full-time as a teacher and being issued an Initial License and Emergency Certificate, the prospective educator must also:

• Complete an additional 15 semester credit hours of coursework in the relevant content area (at least six of those credits must be in pedagogy).

If you already have a bachelor's degree, you may be able to qualify for a <u>Provisional certificate</u>. This is a 3-year, non-renewable certificate that allows you to teach while you complete a certification program. This certificate can only be issued once you are hired to teach in a Georgia school (referred to as a Georgia LUA - Local Unit of Administration). The minimum requirements you must meet before seeking employment are as follows:

- A bachelor's degree or higher;
- Induction level or higher passing score on the appropriate GACE <u>content assessment</u>. These scores are
 transmitted electronically to the GaPSC. If you are seeking employment as a consultative Special Education
 teacher, you are not required to pass the GACE content assessment before being eligible for certification;
- Completion of the Georgia Educator Ethics Assessment (Test Code 360). This score is also transmitted electronically to the GaPSC.

In order to qualify for an alternative program, you **must** be hired as an educator by a Georgia <u>LUA</u>. You must also meet all qualifications for the <u>Provisional</u> certificate. After meeting these requirements, you may apply for admission to the <u>GaTAPP</u> or another provider that works with your employing <u>LUA</u>. Upon completion of the program and any other certification requirements, you will be eligible to convert your Provisional certificate to an Induction or Professional certificate.

**Obtaining a teaching license in Indiana requires completion of an in-state preparatory program or an out-of-state preparatory program. Teacher licensure candidates are also required to complete a Valid CPR certification, Suicide prevention training certificate, hold a valid out-of-state license, and other verifications of educational credentials including testing reports for content area tests required for out-of-state licensure.

Alternative Licensure is also available for special education, advanced degrees in content areas for middle and high school, charter schools, career specialist, <u>America Board</u> Alternative Licensure. Alternative licensure is also available through the <u>Indianapolis Teaching Fellows</u> and <u>Teach for America</u>.

- 1. Must hold a degree and have completed a teacher preparation program in order to qualify.
- 2. All applicants for an initial Kansas license must submit one fingerprint card for the purpose of a KBI and FBI background clearance report.
- If you are applying for an initial Substitute License, have completed a <u>KANSAS</u> teacher preparation program, and have <u>never held</u> a standard teaching license in Kansas, submit <u>FORM 1</u> online.
- To apply for an Initial Kansas Substitute License and you have completed a teacher preparation program outside of Kansas, or a Renewal of a Kansas Substitute Certificate, complete <u>Form 5 here</u>.

**There does not appear to be an alternate licensure program in Kansas at this time.

Completing a teacher preparation program in Kansas seems to be the most direct route.

**The State of Michigan requires licensure to teach. Completing a teacher preparation program and passage of the MTTC Content exam within the state of Michigan will be recommended for certification. Reciprocity programs Interstate Compact Agreement with every state agreeing to accept out-of-state approved teacher preparation programs and standard teaching certificates on a reciprocal basis for initial certification. Under ICA the Michigan Department of Education attempts to match out-of-state certificates, grade levels and content endorsements as closely as possible. Even with reciprocity, Michigan certification is not guaranteed, and ancillary state requirements exist in Michigan law. Out of state teachers will take the Michigan Tests for Teacher Certification. Three years of successful teaching experiences matching the validity of their standard teaching certificate from another state, country, or federally recognized Indian tribe since it was initially issued may be accepted in lieu of the test.

<u>Expedited preparation pathways</u> are available in Michigan for individuals who have completed a bachelor's degree. Many programs are residency programs designed for individuals who are interested in being employed as full time teachers while concurrently working toward certification.

Prospective educators who hold a (non-education) bachelor's degree can complete an approved alternate route program in education from a college or school of education in Mississippi. Each program provides the knowledge, skills and supervised internship experience to teach elementary, middle, or high school in Mississippi.

- Complete the Mississippi alternate route program requirements
- Obtain an online recommendation from your institution

If you haven't completed a teacher preparation program but do have a bachelor's degree earned at an institutionally accredited college or university, you can apply for a <u>Class 5B</u> <u>provisional license</u>. Along with the application, you will have to submit a plan of study from an institutionally accredited college or university that verifies you meet their criteria for enrollment and can complete a teacher preparation program within the three year term of this license. All forms are within the application in the licensing system, <u>TeachMT</u>.

The Class 5B provisional license allows you to teach in the classroom for up to three years while you are completing your coursework. At the end of three years, the Class 5B license will expire and cannot be renewed.

You can upgrade your Class 5B license to a <u>Class 2 standard teaching license</u> or <u>Class 1 professional teaching license</u> any time during the term of the license, as long as you have fulfilled your Plan of Professional Intent.

The Class 5 license is <u>non-renewable</u> and can only be held once per teaching career.

**The State of Ohio requires teacher licensure. There are a variety of licenses available and typically are narrow in scope. First licensure will require a Standard Resident Educator License, for those who have completed a traditional teacher preparation program through an accredited college or university. The Standard Resident Educator License is good for two years.

An <u>Alternative Resident Educator License</u> may be a starting pathway for those who do not qualify for the Standard Resident Educator License. Alternative Resident Educator Licensure holders will be required to complete the Ohio Resident Educator Program to advance to a professional teaching license. This is a two year license.

The one-year provisional credential provides aspiring DC teachers with a pathway to a credential, while simultaneously requiring successful demonstration of basic skills prior to its issuance. This credential is valid for one year from the date of issuance. It is non-renewable and available only to individuals who have never previously held an initial or a standard DC teacher credential.

Requirements

- An earned bachelor's degree from an accredited college or university, or its equivalent if the degree was completed at an institution outside of the United States (US);
- Demonstration of basic skills as evidenced by either of the following:
 - A 3.0 or higher grade-point average (GPA) on a 4.0 grading scale earned for the bachelor's degree. Graduate degree GPAs are not considered, OR
 - Passing scores for the reading, writing, and mathematics portion of an approved basic skills examination. See <u>DC educator testing flyer</u> for approved basic skills exam options;
- Current employment as a regular classroom teacher or evidence of a conditional offer of employment as a teacher with a DC local education agency (LEA);
- Meet satisfactory background requirements; and
- Have not previously been issued a DC teaching credential in any subject area.

All teachers and administrators employed in a Wyoming school district must be licensed in accordance with Wyoming state law. PTSB upholds the highest standards for teacher licensing and requires all educators to have completed an approved teacher preparation program in order to become licensed to teach in a Wyoming school district. There are two routes to teacher licensure in Wyoming.

Traditional: Completing a teacher preparation program in Wyoming

The traditional route to teacher licensure in Wyoming requires the completion of a teacher preparation program from a <u>regionally or nationally accredited institution of higher education</u>. Teacher preparation programs are typically offered through the College of Education at most colleges or universities. The program must include student teaching and lead to a degree in Education in a specific endorsement area or areas. The program must also lead to an Institutional Recommendation for Licensure.

Applicants who have graduated from a regionally or nationally accredited college or university with a bachelor's degree or higher **in education** are eligible for licensure via the traditional route.

Alternative: Completing a teacher preparation program outside of Wyoming.

If you obtain a license in another state through a non-traditional route or alternative method, you may be eligible for licensure in Wyoming if you have taught **3 out of the last 6 years** in the state where you are fully licensed.
