



## Step 1: Click Create




**Step 2:** Enter in Report Name, Date (can be a range), Purpose, Report Type, and Other information as prompted. Click Save.


**Step 4:** Enter in Date of Receipt, Amount, Description (optional), GL account (must), and Allocation (the Index)
