In 1927 religious leaders met in Cleveland in response to organized campaigns of hatred spreading across America. Founded in 1955, today Oberlin Community Services now operates the largest food pantry in Lorain County, helping residents who are struggling with job loss, disability, health issues, and other hardships. OCS also provides emergency rent and utilities relief with an emphasis on preventing evictions, runs an internship program for at-risk youth, and offers educational workshops. The goal is to help create a sustainable and thriving community where everyone flourishes.
